
CSR Update: What is your viewpoint about entrepreneurship Pakistan?

Dr Amjad Saqib: The world makes progress on the basis of entrepreneurship. Entrepreneurship stands for doing a fresh analysis of our social and economic issues so to find out a new solution to these problems. This is all about finding the way to do value addition in our lives and to find innovative solutions to our economic problems and social dilemmas. So an entrepreneur is a very important and useful member of society. An entrepreneur does think as after thinking and deliberations, he finds solutions to our problems. The entrepreneur uses technology and social traditions to find a solution to these problems with use of the available resources. He also possesses the ability to take risks. He does find a passage for us as following in his footsteps will lead us to find our social and economic destination. He does provide such a solution to us, which ensures stability and sustainability in the human and financial contexts. There are two types of entrepreneurs as one is economic and the other one is social entrepreneur. The economic entrepreneurs are those who practice business to seek solutions to their problems. The social entrepreneurs are those who deeply analyze our social issues to do value addition in their lives. CSR Update: In what manner the situation of Covid-19 has affected our lives?

Dr Saqib: Our life after the Covid-19 has not been the same as it was before this pandemic. Our lifestyle, character, method to do business, attend events, all these aspects and activities are being viewed from a new angle. The effects of Covid-19 are not limited just to our economic

life as its impacts are visible on our health, schools, colleges, and universities around us. Entrepreneurship will necessarily be required in the new society being developed to tackle the situation of Covid-19. Innovation will also be required for using technology to find solutions to our problems. The aspect of financial inclusion also gains importance in the context of growing unemployment, poverty, and shrinking of businesses. The solution to all these problems could be sought through the methods of social and financial inclusion as this will lead us to the situation of economic and social sta-



bility. Every Pakistani should be included in the process of financial inclusion so as to provide him or her with the required fiscal resources to combat the situation of Covid-19. We also need to creatively look at the changes in our social life and mutual conduct after the pandemic. The importance of entrepreneurship does in-

crease in the world being transformed due to Covid-19 as we need to use technology to deal with this problem.

CSR Update: Considering the importance what is your opinion about the Corporate Social Responsibility?

Dr Sagib: A beautiful society would not come into existence till the time its three basic components the government, the private sector, and the civil society completely fulfilled their obligations. A society where everybody gets the opportunity to live with honour and dignity. The CSR is not just about the donations given by the private sector to build charitable facilities for people of the remote areas. The important aspect of CSR is related to the conduct of a business organization with its clients, employees, shareholders, and other stakeholders. It is imperative to take care of the rights of the clients in addition to doing community welfare and support programmes for the desired social development and poverty alleviation.

CSR Update: So far how much work you have done in the education sector?

Dr Saqib: We have created an island near Kasur where we have collected youth from across the country. They are from families where income does not exceed Rs 25,000 but have dreams and aspirations to create beauty in this world. We are helping them achieve their goals by educating them for free. It is a boarding college called Akhuwat University.

Boys from across Pakistan - from Fata, KP, Interior Sindh, Balochistan and from villages in South Punjab are studying there. They all secured above 80 percent marks in Matric, took the university test and interview and got in there. Over 321 boys have passed their intermediate exam from there so far and more are pursuing their studies further. They are in medical colleges, engineering universities and in other disciplines, pursuing their passion. Akhuwat stays with them.



Can CSR and the conscientious consumer save the world?

Critics of rampant consumerism are not very impressed by the promise of CSR



Proponents of unlimited consumption feel that the prevailing global production system can keep autocorrecting itself. Besides technologically driven efficiency, two other redeeming precepts which can apparently help save us all from consumerist excesses are corporate social responsibility (CSR) and conscientious or conscious consumerism.

Critics of rampant consumerism are not very impressed by the promise of CSR nor the idea of conscientious consumerism, both of which are dismissed because they try to deal with negative impacts of unbridled profit-driven capitalism with more capitalism.

Consider, how, for instance, CSR basically implies that corporations can self-regulate themselves to minimise harm and to promote social benefits. It includes varied practices ranging from adoption of ethnical production practices to supporting philanthropic activities without tampering with the existing business model of profitability.

Many corporations have been criticised for taking a superficial view of CSR so that it does not undermine their bottom line of maximising profits. CSR has also been accused of serving as a distraction where big brand names accused of polluting waterways, or causing obesity can sponsor music events under the banner of CSR to generate goodwill and further expand their market share. A tobacco company sponsoring a local park similarly does little to alleviate the damage it has caused to people's health.

On the other hand, making people pay extra for organic produce or buy ethically sourced goods for

a higher price are typical examples of consumer conscientiousness, which is still a nascent concept in poorer countries, but now a widespread phenomenon in the so-called 'developed' world.

It is common to go to any grocery store in the United States or Europe and be confronted with the option of buying a carton of a dozen eggs at significantly varied prices. The cheapest eggs are those produced by caged poultry. Cagefree eggs are slightly more expensive. It is much more expensive to get organic eggs. And organic eggs obtained from certified humanely treated and pasture-raised hens are the most expensive. The same idea applies to many other products ranging from milk to coffee, which is sourced through 'fair trade'.

Instead of compelling all industries to pay fair wages to all the workers involved in the production process, requiring these industries to treat animals more humanely, and minimise harm to the environment, the cost of ethical production is being passed onto the consumers.

The conscious/conscientious consumerism hype suggests that every purchase an ordinary consumer makes may become a moral act and an opportunity for ordinary people to use the power of their wallet to change the world. Many people now genuinely believe that if all consumers can be given enough information, they'll be able to make the right choices and compel corporations to act differently.

One wonders if making small, ethical purchasing decisions while ignoring the structural incentives for companies' unsustainable business models, will be able to accom-

plish much. Even if the trend of contentious consumerism were to spread around the world, this phenomenon would remain confined to those who not only have the will but also the surplus purchasing power to make 'ethical' consumer choices.

Contending with issues such as equal pay, environmentally conscious manufacturing processes, prevention of human bondage in global supply chains, responsible farming practices is not easy. Even the savviest consumers cannot be expected to effectively understand the myriad implications related to the production of every single

product they buy each time they go out shopping.

It is thus understandable when self-regulation via corporate social responsibility or consumer consciousness is described as window dressing which cannot by itself compel businesses to adopt more ethical production practices. Unfortunately, powerful business lobbies in industrialised countries, and the vested interests of local elites in poorer countries, continue to resist regulation of big businesses that continue making exorbitant profits by exploiting both people and the environment.

The report, "What's next for social protection in light of Covid-19: country responses" released by the International Policy Centre for Inclusive Growth (IPC-IG), focuses on experiences from countries in Asia, including Pakistan, sub-Saharan Africa, the Middle East and North Africa (MENA), and Latin America and the Caribbean. The deep dive into social protection responses to the Covid-19 crisis highlights Pakistan's effort to tackle poverty amidst the biggest global crisis in more than a century and provides overall lessons for the

Ehsaas averted catastrophe during pandemic: report

The report analyses how the Covid-19 pandemic was a watershed period for Pakistan in terms of government functioning: making protection response to the Covid-19 crisis, the report says, "The Ehsaas Emergency Cash (EEC) programme demonstrated how cash shocks such as the Covid-19 pandemic. The lockdown in Pakistan - the fifth most populous country in the world - affected the livelihoods of 24.9 million."

The study reveals that social protection had been an integral component of Pakistan's response to the crisis. "In response to the economic impact of the pandemic, the government of Pakistan launched the emergency cash transfer scheme and delivered approximately USD1.1 billion to 14.8 million families at risk of extreme poverty. Each low-income household received a one-time payment of USD75, enough to buy staple food items for the four months."

Detailing the problems caused by the pandemic to different sectors, the report says that poverty on the streets was more than a statistic; it could be seen in the stories of every other Pakistani's life. Labourers found themselves suddenly unemployed, with their families on the verge of starvation. Hawkers who would rely on daily sales from their stalls were forced out of work. Staff from otherwise busy hotels and restaurants were suddenly left sitting at home. Domestic workers such as part-time gardeners, security guards, drivers and industrial daily wagers were laid off. Fishermen, miners, transport contractors, bus drivers and hawkers in bus stations were suddenly out of a iob. Beauticians and barbers, otherwise making a decent living, found themselves with no customers. Millions of shopkeepers with their savings consumed faced hunger, living behind the shutters of their closed shops. Private-school teachers received severance letters; electricians, welders, painters, carpenters, plumbers, car mechanics and construction labourers did not know where their next meal was coming from; and taxi drivers did not see a passenger for weeks on end. This was the story repeated across industries and geographies.

Further, the report highlights that the EEC programme helped change the situation and augmented the digital infrastructure already in place and followed a hybrid targeting approach to identify beneficiaries. The programme accelerated the adoption of cost-effective, digital initiatives that enabled new ways of coordinating across multiple stakeholders and deploying a whole-of-government approach.

This can lay the ground for improving the coverage and shock-responsiveness of social protection systems, the study suggests. Yet, for this to happen, it is key that the lessons learned and the gains made during the Covid-19 responses are incorporated into the national social protection systems, such as by levering databases used for emergency responses, for example, the report notes.

PAC committee asks ministry to judiciously spend CSR funds

sub-committee of the Public Accounts Committee directed the Ministry of Petroleum to formulate comprehensive guidelines and programme to judiciously spend the funds collected from petroleum companies under corporate social responsibility (CSR).

The companies are bound to give \$25,000 to \$250,000 annually to the government under CSR function for capacity building and some other purposes. Out of this amount, 30 percent receives federal government, 30 percent the provincial government while 40 percent is spent on the capacity building of the Pakistani employees engaged by these companies.

The committee met under the chair of Syed Naveed Qamar of Pakistan Peoples Party at Parliament House and discussed the audit paras of the petroleum division.

Briefing the committee on audit para regarding less recovery of training funds from the petroleum exploration and production companies, the Director General Petroleum Concession said that an amount of Rs2.6 billion was collect-

He said that out of the total funds received, Rs2.3 billion had been utilised including Rs89.61 million on salaries, Rs25.92 million on trainings, Rs5.80 million on scholarship for locals, Rs14.40 million on local litigation, Rs2212.2 million on international litigation and Rs51.43 million on miscellaneous expenditures.

The chairman of the committee expressed extreme displeasure over the data shared with the committee and questioned that how the funds received under CSR obligation could be used for litigation or some administrative purposes. He questioned under which law and capacity authorisation of funds for any other purpose than the welfare of local people and capacity building of the employees were utilized.

"This is the clear case of financial irregularity and I want to send it to National Accountability Bureau but I am not sending it as the NAB is also not doing any work nowadays," he added.

Another member of the committee, Hina Rabani Khar, declared the misuse of funds as criminal act and said it seemed that the whole system of the country had broken and no law prevailed.

The Director General Petroleum Concession could not satisfy the committee on use of funds for aforementioned purposes. Secretary Ministry of Petroleum Mian Asad Hayaud Din accepted that the present guidelines to spend said budget were vague and needed improvement.

He informed the committee that there were Rs1.4 billion stashed with the ministry under same head and sought time to prepare a comprehensive policy and plan to spend it more transparently and judiciously in future.

The matter was deferred by the committee till next meeting.

Meanwhile, the committee was also briefed by the heads of Oil and Gas Development Company Limited (OGDCL) and Pakistan Petroleum Limited (PPL) about their respective CSR initiatives.■

OGDCL spends Rs 10.22m in Lakki Marwat under CSR

The Oil and Gas Development Company (OGDCL) is spending an amount of Rs 10.22 million, under its Corporate Social Responsibility (CSR), in Lakki Marwat district of Khyber Pakhtunkhwa.

"The Wali, Mianwali and Pezu blocks partially fall in District Lakki Marwat, and the OGDCL has deposited Rs 10.22 million in the joint bank account of the concerned deputy commissioner as per its social welfare obligation," according to an official document available with APP.

The company has so far executed three different schemes approved by the respective social welfare committee, headed by the local Member National Assembly, at Rs 6.7 million, while Rs 3.52 million were still available with the DC Lakki Marwat to initiate new development schemes. The OGDCL said appointments were made in accordance with criteria

approved by its Board of Directors, and currently as many as 67 contractual and regular employees were working with it, who had the District Lakki Marwat domiciles.

"Moreover, considering the nature of business activities, the temporary interim arrangements of manpower are often made, preferably from locals of the area. At present, 17 service units of local manpower as project workers have been engaged through a 3rd party contractor at Rig N-6 of the Wali X-1 till completion of the project," it added. It said the total land of Wali X-1 field was 287 kanals 14 marlas, consisting of Shamlat Deh, and was hired on an annual rental basis. ■

Other notable guests included officials from the Ministry of Commerce, Ministry of Industries, Board of Investment, Additional Attorney General of Pakistan and representatives of Lahore University of Management Sciences (LUMS), WWF Pakistan and senior management from CCI Pakistan. This detailed study was conducted by Kashif Malik, Professor Lahore University of Management Sciences (LUMS). statement is the important aspect of your company, which tells as for what aim your company does exist and what are the methods to be used to secure this objective. The mission statement of a company should reflect its key steps like new products, marketing plans, and business initiatives. No bailout for the poor

he situation is tough. The third wave of Covid-19 is threatening. Ensuring sufficient supply and efficient administration of vaccines is hard. The revival of the International Monetary Fund (IMF) programme provided some measure of comfort to the planners. To appease constituents, however, the PTI government needs to do more. Innovative ideas and alternative channels can be deployed to deal with high levels of joblessness and rising living costs.

The corporate relief package has revived the formal economy but the recovery appears to be jobless. The containment of food inflation seems to be on the government's agenda. The ruling party, however, does not seem to pay attention to Covid-19induced unemployment. It probably assumed the measures targeting the revival of the economy would address the issue. Perhaps the job-creating potential of the corporate sector in Pakistan is limited. Besides, the big business wary of labour issues prefers to be leaner and inclined to opt for contractual workers for noncore operations to meander

around labour laws.

The corporate relief package has revived the formal economy, but the recovery appears to be jobless

For job creation, therefore, the government will need to extend support to establishments operating under the radar. To cater to the needs of a sector that by definition is unrecorded can't be straight forward. It will require rigorous planning and execution.

Job creation in an underperforming economy is not just a social issue. It is a matter of cropping the opportunity cost of idle resources in men and material. After all, services offered by the informal sector have a market and are critical to citizens' needs (house help, plumbers, electricians, groomers, tailors, tutors, caterers, runners, car cleaners and technicians, veggie and fruit vendors, etc).

"If the government can provide an amnesty to builders and developers in the construction sector to achieve a greater goal of wealth creation, it can find ways to reach out to informal businesses for job creation," commented an economist while discussing



the collapse of the parallel economy in the wake of the pandemic.

Dr Hafiz A Pasha, former finance minister and a leading economist, shared strong views on the subject that he said pained him. "It is sad to watch this level of suffering. The income of working families is falling and the cost of living is rising, making life miserable for so many. The government can't be absolved of the responsibility. Why did it not support the collapsing small businesses when it went out of the way to help the corporate sector? There is no defence for neglecting a sector that engages more than half of the workforce.'

He made a case for extending a Rs500-600 billion micro-credit line to fix the broken financial cycle of small businesses through credible institutions such as Kashf Foundation.

Dr Nadeem Javed, former chief economist of the Planning Commission, concurred with Dr Pasha. "When 68pc of the workforce of the informal sector is in distress, the whole society is affected. In smaller towns, one can spot a new crop of beggars on streets. By closing eyes, problems will not disappear. To avoid grave ramifications later, the ruling party must act now and extend support to tiny firms that need it the

A recent article on the informal sector on the World Bank Blogs website mentions, "More than 80pc of all South Asia's workers engage in informal activities, and more than 90pc of the region's businesses are

informal. Even in many formal firms, a large proportion of employment consists of informal workers. In Bangladesh and Pakistan, informal workers are the majority within formal firms".

Discussing the impact of Covid-19, it states: "For Bangladesh, India and Pakistan, the poorest third of the population relying on the informal economy lost 9, 13, and 16pc of their incomes, respectively." The writers advised the policymakers to consider providing relief to distressed firms through alternative channels, such as microfinance institutions.

A conversation with affected people revealed the gravity of the crisis. Ghaffar. who is an electrician living in Shireen Jinnah Colony in District South of Karachi and works in DHA, was forthcoming while discussing the woes of his social class. He came to Karachi from Vehari, Punjab, back in 2002 as a boy. Initially, he was hired as a house help. Then he became a cook and finally a driver. When his brother trained as an electrician, he started assisting him on holidays. He soon left his job and started working as an electrician first in a shop and then independently.

Hard work and good reputation ensured steady income, but since last year, the pressure of catering to the very basic needs of his family has been crippling, he says. "I somehow make do though my monthly earning Rs18,000-20,000 is barely half of what it was before the lockdown." Explaining the reason for a

drop in income, he said, "The commercial area is slow and many restaurants where I served on retainer closed down or are working on leaner employee strength."

"In my locality today, every other person is unemployed. My relative, a driver for the past 20 years, is jobless for the last six months. Two of his three married daughters got divorced and returned home with their children this past year. I don't even want to imagine what it must be like for him."

Nadir, a tailor master, had to close down his shop at Gizri as the rent of the place piled up. He had to auction his sewing machines to clear his liabilities. Months of struggle for bare survival has weakened Nadir's resolve to earn an honest living. He said he is unsure if he can turn down a work offer on moral grounds any longer. "It would have been easier had we all contracted Covid-19 and died," he said in utter despair while talking to Dawn in his tiny shack of a house in Qayumabad.

"With the help of the establishment, the government might be able to manage the opposition, but dealing with public disenchantment will be harder. Had it been possible to sustain a government without public support, powerful dictators in the past wouldn't leave," commented a political economist.

The relevant ministers and secretaries were approached, but they did not respond to calls and messages.



The compulsory need to wear a face mask and observe other safety precautions against the coronavirus doesn't end in the present times even after getting vaccinated against the deadly viral disease.

Chief Executive Officer of Indus Hospital Dr Abdul Bari Khan stated this as he delivered the keynote speech at a seminar titled "Business responses to Covid-19 pandemic" organised by the National Forum for Environment and Health

He said that observance of the safety precautions against the deadly infectious disease remained compulsory even after vaccination as the human body required some days after the inoculation to develop the immune system against the coronavirus.

He said that lockdown measures should be strictly implemented in Sindh as had been done last year during the first phase of the viral epidemic as there shouldn't be any leniency in this regard.

He said the concerned authorities in the province should remain fully prepared to tackle any adverse situation in the province due to the looming threat of the UK variant of the lethal virus as there shouldn't be any laxity in this regard.


























In addition to this, the NFEH has been regularly organizing conferences, seminars, brainstorming sessions and roundtable discussions to highlight issues relating to the degradation of the environment in the country.

Moreover, the NFEH actively liaises with the provincial departments of local government and the environment and with the Federal Ministry of Climate Change to conduct tree plantation campaigns across the country. The forum has been partnering with the Government of Pakistan to further the Clean and Green Pakistan initiative of the Prime Minister.

The NFEH has also been facilitating a number of corporate, business and industrial entities in the country to run forestation campaigns at their offices and processing and industrial units.

The NFEH points out to the provincial environmental watchdogs instances of irreversible damage to the environment resulting from certain unchecked industrial and commercial operations in the major cities. The forum has been associated with a number of beach cleaning campaigns in Karachi.

The forum has supported several initiatives undertaken to reverse the trend of climate change and to restore the wildlife habitats to protect the endangered species in the country. These are some of the measures the NFEH has been actively taking to prove that the forum is a conscientious and responsible member of the Pakistani civil society



CPHGC successfully completed all its tests, as required by the Government of Pakistan and announced its Commercial Date of Operations on 17 August, 2019.

The CPHGC Project not only reflects the economic cooperation between China and Pakistan but also represent the deep bond of friendship between the two countries. After the commercial operation of the project, it has effectively eased up the situation of Pakistan's electricity shortage and will bring considerable tax revenue and employment opportunities whilst at the same time continue to promote Pakistan's economic and social development.

International Steel Limited (ISL) was incorporated in 2007 with the vision to be the foremost manufacturer offlat steel products in Pakistan. ISL was set up with an initial investment of \$165 million investment, with equity contributions from IIL, Sumitomo Corporation, JFE-Japan and the International Finance Corporation (A division of the World Bank) which bought added impetus and confidence in the engineering and hi-tech manufacturing industry in Pakistan. IIL owns 56.335% of the share capital of ISL. The company continues to grow and diversify its business. Initially, ISL was capable of producing 180,000 MT per annum of hot dipped galvanized coil (HDGC), and 250,000 MT per annum of cold rolled coil (CRC). in 2016 and enhanced its galvanizing HDGC capacity to 462,000 MT. A second stand on the rolling mill was added in 2016 upgrading ISL's CRC capacity to 550,000 MT. In June 2018, ISL completed additional expansion to enhance its production capacity to 1 million tons. ISL is today the largest manufacturer of flat steel products in Pakistan, with gross sales of roughly Rs. 65 billion in 2018-19. Going forward, sky was the limit and Crown Group grew year after year, exploring, manufacturing and introducing new products to the Pakistani market. The group entered the business of local motorcycle body parts, motorcycle assembly, CNG rickshaw parts, lubricants, tyres and ultimately moved towards an industrial park for motorcycle parts makers.








KOHINOOR MAPLE LEAF GROUP

Second is limiting our environmental impact by reducing water and energy consumption while increasing our recycling efforts. Third is upskilling our people while uplifting the communities we serve by sponsoring various drives and initiatives to reduce hunger and malnutrition while promoting health and wellness.

Before acquiring the current Kirthar Concession (Block No. 2667-7), PGNiG operated and carried out exploration activities in four other Concessions namely Khanpur West, Sabzal, Mekhtar and Sabzal South. PGNiG has also held a 40% Working Interest in an exploration block in



Nawabshah, Sindh as a Non-Operating Partner. PGNiG acquired the Kirthar Block, located in District Dadu (Sindh), as the operator in 2005 and Pakistan Petroleum Limited (PPL) farmed-in the Block as a Joint Venture Partner in 2006. PGNiG made the discovery of Rehman-1 well in 2009 and started extended well test (EWT) production from it in 2013 hence, becoming the first "Tight Gas" producer in Pakistan. The appraisal phase for Rehman gas field was successfully concluded in August, 2015 whereby commerciality of the field was declared. The Government of Pakistan awarded a Development and Production Lease over Rehman field in 2017 for a period of 25 years.

In 2015, PGNiG made a second discovery by drilling Rizq-1 well in the Kirthar Block. This year also earmarks the commissioning of the Rehman Production Facility (RPF) which was constructed to process the produced gas from Rehman and Rizq fields.■
